FORMING NATURALLY LEWIS, INC.

Naturally Lewis, Inc., a new not-for-profit leading economic development efforts for Lewis County, was developed in October of 2023. This effort is a result of a growing partnership between the Lewis County IDA, Lewis County Development Corporation and the Lewis County Chamber of Commerce. The multi-year initiative, led by staff to consolidate services and maximize resources to provide Lewis County with a one-stop-shop for business, tourism, and economic development, is a reflection of our communities; it is a direct result of its needs.

LEADING A REGIONAL TOURISM EFFORT

With the development of Naturally Lewis, Inc. Lewis County's tourism development and promotion efforts are improving. In 2023, Naturally Lewis facilitated discussions with the tourism promotion agencies of Jefferson County, Oneida County, and Oswego County, and the Tug Hill Tomorrow Land Trust and the Tug Hill Commission to propose a streamlined, united effort to promote the Tug Hill Region.



Naturally Lewis, Inc. has partnered with the Village of Lowville and Lewis County Planning & Community Development to submit an application to the NYS Downtown Revitalization Initiative program on behalf of the Village of Lowville. The application included various small business and tourism development projects, resulting in an improved quality of life for residents that will produce a ripple effect of positive change. The Village of Lowville application was selected to receive \$10million!



As a placemaking initiative, Naturally Lewis partnered with local business, Rags & Rivers, to host its inaugural *Art in the Park* event at the Lyons Falls Riverside Park. *Art in the Park* is an outdoor art exhibit bringing artists together to create a sense of community. Launched in conjunction with Food Truck Fridays, this event brought over 20 artists and over 500 community members together!

STAFF TRANSITIONS TO NATURALLY LEWIS, INC.

Naturally Lewis, Inc., the new not-for-profit leading economic development in Lewis County, has developed operational policies with its formation. Included with this, there are now Staff Service Agreements in place where Naturally Lewis, Inc. is contracted by the Lewis County IDA, the Lewis County Development Corporation, and the Lewis County Chamber of Commerce, to administer the services of those entities. We now have a staff of 5, and are looking to grow the team by adding a Finance & Operations Manager in early 2024.

CRAFTING POLICY LEADING TO IMPACT

A PILOT (Payment in Lieu of Taxes) is an agreement between the Lewis County IDA, a public authority of the state created to provide incentives, and a business or property owner. The business, upon successful expansion, makes payments to the LCIDA at an abated rate, which then are disbursed to the affected taxing jurisdiction. PILOT policies are important in rural areas because they can encourage businesses to invest and operate there by offering tax incentives. In rural areas where economic development may be more challenging, PILOT policies can help attract businesses, create jobs, and stimulate local economies. These policies can also provide muchneeded revenue for essential services like schools and infrastructure, helping to support the overall well-being of rural communities.

BRINGING PROJECTS TO FULL TAXATION


The County of Lewis Industrial Development Agency (LCIDA) scaled two projects into full taxation in 2023! These projects, Red Barn Meats and WPS Beaver Falls, have used Payment in Lieu of Taxes (PILOT) incentives to develop a project which otherwise would not have happened in Lewis County, and allowed them sustainable growth as they developed.

UNIVERSAL TAX EXEMPTION POLICY UPDATES

Throughout 2023, Naturally Lewis has been connecting with the community to redevelop its Uniform Tax Exemption Policy (UTEP) to fit our current and future needs. Changes to the policy include tax abatement schedules and incentives for both new construction and adaptive reuse of existing buildings. By implementing these changes, we can spur new development while also preserving our history through revitalization of existing structures. It's expected that this new policy with be approved and implemented in early 2024!



WHAT IS A UTEP?

Universal Tax Exemption Policy (UTEP) is a governmental initiative designed to promote economic development within a region by offering tax incentives to businesses. Under a UTEP, eligible businesses may receive exemptions or reductions on various taxes, such as property taxes or taxes on equipment and machinery. These exemptions are often granted for a predetermined period and are intended to encourage businesses to invest in the local economy, expand their operations, and create jobs. UTEPs are typically implemented at the local level and are tailored to the specific needs and goals of the community.

UTEPs are important tools for fostering economic growth and revitalizing communities. By incentivizing businesses to invest in a particular area, UTEPs can spur job creation, attract new businesses, and stimulate overall economic activity.



LEWIS COUNTY LEADERSHIP ACADEMY

With our partnership with the Lewis County Chamber of Commerce, Naturally Lewis has began facilitating the Leadership Academy. We've created a learning community that puts professionals (existing and emerging) in a position to influence and add value to Lewis County. We build pride in our local history and culture, and create highly skilled, motivated, and informed leaders. Using a growth mindset, we are 'open to possibilities' and use our knowledge and networks to enhance our civic infrastructure to create a more vibrant quality of life for all.

FURTHERING OUR ENTREPRENEURIAL ECOSYSTEM

Naturally Lewis has worked to develop Lewis County into an "entrepreneur-friendly" community. By transitioning our DBA Lewis County initiative from a program into what we do, we have streamlined connectivity to further our entrepreneurial ecosystem. By assisting member and non-member clients, Naturally Lewis has cultivated an ecosystem that everyone can be a part of and everyone can take pride in.

MODERNIZING MEMBERSHIP

REVIVING THE LOWVILLE BUSINESS ASSOCIATION

In a bid to inject vitality into the local business landscape, a group of the Lewis County Leadership Academy Class of 2023, under the guidance of Naturally Lewis, took on the initiative of analyzing the Lowville Business Association (LBA) for revitalization. Once dormant, the LBA was reinvigorated through the group's strategic SOAR analysis, leading to an infusion of fresh energy.

The community has embraced the LBA's vision, recognizing its value in fostering community and local pride. With a committed board and community support, the LBA is well on its way to becoming a pivotal force once again, driving economic growth and unity in Lewis County.



HOSTING THE LC ECONOMIC DEVELOPMENT CONFERENCE

Naturally Lewis hosted its second annual Lewis County Economic Development Conference in 2023. The theme, From the Ground Up, understood the roots of our economy and our businesses and provided how to use this foundation to develop a thriving rural economy. The conference attracted over 120 attendees from across New York State, and highlighted Lewis County as the natural choice.

COMMUNITY ECONOMIC DEVELOPMENT PROGRAM

The Lewis County Community Economic Development Program, funded through a Host Community Agreement between the LCDC and Invenergy, is the mechanism for investing in initiatives that build a great quality of life, sustainable employment and collaborative plans that make Lewis County a community to thrive at work and at home. In 2023, Naturally Lewis opened three grant programs - the Small Things, Big Impacts Fund, the Building Business Fund, and the Community Connections Fund - to invest \$150,000 annually in Lewis County. VACANT PROPERTY REVITALIZATION

Naturally Lewis, in partnership with Lewis County, created the Vacant Property Revitalization (VPR) Fund to target vacant and potentially unsafe or blighted properties within downtown and surrounding areas to turn them into usable spaces for business development opportunities. The LCDC, through its Round 1 Application process, approved nine projects, granting a total of \$690,965 in VPR funds.


GLENFIELD SCHOOL DEVELOPMENT

Naturally Lewis, in partnership with Lewis County, requested expressions of interest for the development of the former Glenfield School in 2023. This request led to a connection with and winning proposal from the Rochester's Cornerstone Group, who plans to develop and revitalize the former school into a affordable senior living facility. This external investment has great economic potential for the community of Glenfield, and Lewis County as a whole.



SECURED GRANT FUNDS

In 2023 Naturally Lewis secured a number of outside sources of funding for business & tourism development initiatives. Our funding resources include the NYS Office of Homes & Community Renewal Community Development Block Grant (CDBG), Invenergy/Number Three Wind Host Community Agreement for the Community Economic Development Program, Lewis County American Rescue Plan Act funds for Vacant Property Revitalization, National Grid Project C, and the NYS EDA Tourism Partner Sub-Awards Grant Program.


